

**Buddig Thanks to Meal Makers Promotion
Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL

The Buddig Thanks to Meal Makers Promotion (the "Promotion") consist of a Sweepstakes (the "Sweepstakes") and a Contest (the "Contest"). Promotion begins on June 1, 2018 at 12:01 a.m. Eastern Daylight Time ("EDT") and ends on August 31, 2018 at 11:59 p.m. EDT ("Promotion Period"). The sweepstakes consists of thirteen (13) weekly entry periods (each, a "Weekly Entry Period"). Each Entry Period is understood to begin at 12:01 a.m. EDT on the first day and end at 11:59 p.m. EDT on the last day of each Entry Period.

ELIGIBILITY: Promotion is only open to legal residents of the fifty (50) United States and the District of Columbia, 18 years of age or older at the time of entry. Void where prohibited. Employees (and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related) of Carl Buddig & Company ("Sponsor") and each of their respective parents, affiliates, subsidiaries and advertising and promotion agencies are not eligible to enter or win. By participating, entrants agree to be bound by these "Official Rules" and the decisions of the judges and/or Sponsor, which are final and binding on all matters relating to this Promotion. Promotion is subject to all applicable federal, state and local laws.

HOW TO ENTER: During the Promotion Period, there are two (2) ways to enter: **1) Website:** Visit thankyou.buddig.com (hereafter, the "Website") and follow the instructions to complete the entry form, then create and submit a video no longer than sixty (60) seconds in length with their story thanking their favorite meal maker ("Entry") and submit to receive one entry into the contest and sweepstakes. **2) Mail-in:** To receive one (1) Sweepstakes entry without posting a Contest entry or visiting the website above in each Weekly Entry Period, on a 3" x 5" piece of paper, hand-print your name, complete address, phone number (including area code), date of birth, and email address and mail in an envelope with proper postage affixed to: Buddig Thanks to Meal Makers Promotion, PO Box 280267, Nashville, TN 37228. **Entries must be received by or postmarked by August 31, 2018 at 11:59 p.m. EDT to be eligible.** The date and time on postmarked mail-in entries will determine which Weekly Entry Period you are entered into. Entries not received during the Promotion Period will not be accepted. Entries that are late, lost, stolen, misdirected, garbled, delayed or non-deliverable due to any reason whatsoever, including without limitation, delivery problems, internet connection problems, will not be accepted.

VIDEOS MUST BE NO LONGER THAN SIXTY (60) SECONDS IN LENGTH. VIDEOS LONGER THAN SIXTY (60) SECONDS IN LENGTH WILL BE DISQUALIFIED. Videos must be submitted in MPG, MPEG, MPEG-2, MP4, WEbM, MOV or FLV format. Video must not exceed 50MB in size. A 4:3 or 16:9 aspect ratio will be allowed as long as it complies with the time, file size, format and resolution requirements set forth above. All eligible Entries received by Sponsor may be posted on the Website for public viewing. Entrants understand and agree that all posted Entries will be formatted, edited or otherwise converted in order to be viewable on Sponsor's video player on the Website. Sponsor reserves the right to remove any posted Entry from the Website at any time and for any reason.

Once an Entry is submitted, it cannot be modified in any manner by entrant. Limit of one (1) Contest Entry and one (1) Sweepstakes Entry per person using only one (1) email address per promotion period. Entries received from any person or email address in excess of the above stated limitation will be deemed void. Each Entry will be deemed to have been submitted by one (1) entrant, regardless of the number of people who might appear in or otherwise help create an Entry. In the event of any dispute concerning the identity of any entrant, the Entry will be deemed submitted by the natural person who is the authorized holder of the transmitting user account. Sponsor's computer is the official time keeping device for the Promotion. Entries generated by script, macro or other automated means and Entries by any means which subvert the entry process are void.

All Entries become the sole property of the Sponsor and may be used by Sponsor in any manner, in any media, now known and hereafter devised, worldwide, in perpetuity. To the extent that an Entry uses Sponsor's products,

In addition, if any other persons appear in a Video or any part of an Entry, entrant agrees that prior to submitting their Entry, entrant has obtained the written consent of each such person who appears, granting Sponsor and its assignees the use of each person's name, biographical information, voice, performance, photograph/video, image and/or likeness for programming, advertising, publicity and promotional purposes in any and all media, now or hereafter known, worldwide and on the Internet, and in perpetuity by Sponsor and its assignees, without compensation (except to the extent prohibited by law) or additional consents and without prior notice, approval or inspection, and to execute specific written consent to such use if asked to do so. Sponsor reserves the rights to request proof of these permissions in a form acceptable to Sponsor from any entrant at any time. Failure to provide such proof, if requested, may result in disqualification, at Sponsor's sole discretion.

By submitting an Entry, each entrant acknowledges and agrees that Sponsor reserves the right to edit or otherwise revise each Entry for any reason, including without limitation, for creative reasons, for technical reasons, etc.

REQUIREMENTS OF ENTRIES: Videos must conform to the following:

- **NO LONGER THAN SIXTY (60) SECONDS IN LENGTH (Entries more than sixty (60) seconds in length will not be accepted).**
- **50MB or less in size.**
- **Submitted in MPG, MPEG, MPEG-2, MP4, WEbM, MOV or FLV format.**
- **Video resolution must be no lower than 400 x 300.**

Either a 4:3 or 16:9 aspect ratios will be accepted as long as it complies with the time, file size, format and resolution requirements set forth above.

Entrants may not contract with, or pay for, any outside consulting firm, agency, or other service for any assistance or guidance in the creation of the Entry. The Entry must consist solely of the original work of the entrant. The entrants represent and warrant that the Entry is suitable for display or publication; it does not contain any obscene or pornographic material, it does not depict in any way any individual under 18 years of age, does not contain any defamatory statements, it does not contain words or symbols that are widely considered offensive to individuals of a certain race, ethnicity, religion, sexual orientation or socioeconomic group, it does not include threats to any person, place, business or group, it does not contain any references to alcohol, controlled substances or other unlawful activities, it does not invade the privacy or other rights of any person, firm or entity, It does not contain trademarks, logos, or trade dress (such as distinctive packaging or building exteriors/interiors) owned by third parties other than appropriate Sponsor's products (as referenced above), does not contain any third person's personal information, such as personal names or e-mail addresses, does not contain materials owned by third parties (including photographs, sculptures, paintings, and other works of art or images published on or in websites, television, movies or other media), does not contain materials embodying the names, likenesses, voices, or performances identifying any celebrities and/or other public or private figures, living or dead or the names, likenesses, voices, or performances of any individual other than entrant without their permission, does not communicate messages or images inconsistent with Sponsor's reputation, image and/or goodwill, does not violate any law or regulation; or is otherwise inappropriate, objectionable, or unsuitable for the uses contemplated in these Official Rules, including for broadcast, as determined by Sponsor in its sole discretion.

All Entries will be reviewed for content before being judged; however, such review does not relieve the entrant from responsibility for compliance with all of these Official Rules. Entries that do not comply with these Official Rules or that otherwise contain prohibited, or inappropriate contents as determined by

Sponsor, in its sole discretion, will be disqualified and will not be considered for any prize. Sponsor in its sole and absolute discretion, makes the final determination as to which Entries are eligible to take part in this Contest and be considered for a prize.

VOTING: Entries will be moderated for content. Once Entry is reviewed the user will receive an email with the status of their submission. If approved, the video will appear in a gallery for viewing and voting on the Website. To vote users will click a vote icon and follow the prompted instructions to submit their vote. **Limit of five (5) votes, one per video, per person using only one (1) email address per day.**

JUDGING: Potential Grand Prize, 1st Prize and 2nd Prize winners will be selected in two (2) judging phases. In each phase, eligible Entries will be judged on the criteria set forth below. Entries will be judged by a panel of experienced marketing and advertising professionals in both phases. Winners will be selected from all eligible Entries on or about September 14, 2018.

Phase 1: All eligible Entries received by Sponsor will be judged by the Administrator based on the following criteria: Authenticity- The story is conveyed in a manner which evokes emotion, serving as an inspiration/motivational tool for the viewer (25%), Contextual Relevance- The video is relevant and appropriate to the indicated theme (25%), Audience Appeal- The video is family friendly, attractive and resonates amount a larger audience, increasing the propensity to share (25%), Quality of Video- The submission pieces capture the essence of the Promotion in a impactful way (15%), Vote Count (10%) (the “Judging Criteria”). Subject to verification of eligibility and compliance with these Official Rules, the twenty five (25) Entries with the highest overall scores will be deemed finalists (“Finalist Entries”) and will advance to Phase 2. In the event of a tie, the Entry(ies) with the highest score in the Quality of Video criterion will be determined a Finalist Entry. Sponsor reserves the right to advance fewer than twenty five (25) Finalist Entries to Phase 2 if, in its sole discretion, it does not receive a sufficient number of eligible Entries throughout the Promotion Period.

Phase 2: The Finalists Entries will be judged based on the Judging Criteria provided above by a separate panel of judges consisting of Sponsor’s representatives. The one (1) Finalist Entry with the highest score will be declared the potential Grand Prize winner. The four (4) Finalist Entries with the next highest scores will be declared the potential First Prize winners. The twenty (20) Finalist Entries with the next highest scores will be declared the potential Second Prize winner. In the event of a tie, the Entry with the highest score in the Quality of Video criterion will be determined the potential winner of the applicable prize.

RANDOM DRAWINGS:

Five (5) potential Sweepstakes Weekly winners will be selected in a random drawing for each Weekly Prize Entry Period on or about the dates specified below from among all eligible entries received for each Sweepstakes Weekly Prize Entry Period. The odds of winning a weekly prize depend on the number of eligible entries received for each applicable Sweepstakes Weekly Prize Entry Period. FINALIST NOTIFICATION AND REQUIREMENTS: Each potential Finalist will be notified by email on or about November 1, 2018 at the email provided in his/her registration as of the date of the Entry of his/her Entry and will be required to complete an Affidavit of Eligibility, Liability and Publicity Release (unless prohibited by law) and any other documents required by Sponsor, all of which must be returned within five (5) days from the first attempted notification. Potential Finalists who fail to provide any of the documents or assets set forth above within five (5) Days of first attempted notification, including without limitation, affidavits, consents, will be disqualified. Return of notification as undeliverable, failure to complete and return requested documentation within the specified time period, the inability of Sponsor to contact a potential Finalist within a reasonable time period (whether due to a change in email address or otherwise) or noncompliance with these Official Rules by the potential Finalist will result in disqualification and, at Sponsor's sole discretion, a runner-up Finalist may be selected and notified for the applicable prize.
